Appellate Court of Appeals of the Commonwealth of Massachusetts
Decided: Dec. 20, 1969. Appeal from the Superior Court of Massachusetts, Suffolk County, No. 68-2000.
Plaintiff, a Negro, filed a complaint against defendant, a Negro, for assault and battery. Plaintiff was
in a barbershop, and defendant, who was also in the shop, struck plaintiff in the face. Plaintiff
brought suit for damages. Defendant denied the charge and asserted that plaintiff had
provoked him by making a racial remark. Plaintiff's attorney, in his opening statement,
stated that he would call as a witness the manager of the barbershop, who would testify
that defendant had been in the shop on previous occasions and had been seen to make
racially derogatory remarks to other Negroes. The trial court denied plaintiff's motion
for a directed verdict. Plaintiff was found guilty and awarded damages. Plaintiff appealed
to the Appellate Court.
